**RE:** Notice of Opportunity: Granville Island Council

We are pleased to announce a momentous and positive change in Granville Island's governance structure as of November 30, 2018.

A new Granville Island Council is being formed, which will be responsible for key decisions pertaining to Granville Island's long-term strategy, budgeting and planning. It will be composed of seven members: two appointed by CMHC, and the remaining from the local community, including one appointed by the City of Vancouver.

The new governance structure is key to Granville Island's future because it puts decision making authority in the hands of local people who understand Granville Island and its importance to the community.

It is based on recommendations in the *Granville Island 2040: Bridging Past & Future* Report (May 2017), which called for a more robust structure to further strengthen local authority, autonomy and decision-making, while remaining accountable to the Government of Canada through CMHC.

Following the release of the report, an interim 2040 Implementation Committee was established to maintain the momentum of determining the most appropriate governance model.

Watson Advisory, a leading Vancouver governance firm, worked with CMHC-Granville Island, the Granville Island Trust, and the 2040 Implementation Committee to propose governance options, roles and responsibilities.

Prior to the formation of the new Council, the Granville Island Trust acted in an advisory capacity to the management of CMHC-Granville Island. Their long standing contribution has been considerable and is greatly appreciated.

It is anticipated that the new Council members will be announced in spring 2019.
