### Council Working Groups – For Input

At its May 25 meeting, Council established eight Working Groups made up of members of staff and Council. Since May 25, the following Council Working Groups have met: Diversity, Equity and Inclusion) DEI; Leasing; Arts and Culture; IWDS; and Budget. Council provided preliminary feedback on Working Group processes. Input included:

# Council Strategic Plan Implementation Framework Workshop - For Input

Council discussed the Strategic Plan and Implementation Framework. Input included:

- The draft Strategic Plan is very close to being complete, and needs tweaking, rather than a more substantive rework requiring a workshop
- The draft should include more specific language around goals
- Subsequent implementation strategy should detail specific actions, roles and responsibilities, timelines, budgets
- Each action should include metrics
- Timelines for implementation should be ambitious, but need to be realistic as well
- The Working Groups are good opportunity to discuss actions
- The goal should be for the Plan to be made public

Council directed staff to prepare a new draft of the Strategic Plan based on this input for Council review at its next meeting.
