Update on Open Consumption Pilot

Shazeen Tejani, Senior Planner provided an update on the Open Consumption Pilot Project for Spring/Summer 2023.

- Council expressed overall support for the project;
- Council suggested monitoring the impact to restaurants throughout the pilot project and exploring opportunities for marketing support to restaurants.

Coastal Adaptation Plan Presentation and Discussion

EcoPlan consultants presented an outline and workplan for a Coastal Adaptation Plan and presentation brief for Council and management to use. Follow-up to previous Council presentations.

- Council expressed support for continuing this work;
- Council suggested developing a public engagement strategy and engaging the arts community;
- Council recommended exploring multiple avenues for funding including advocating to the Federal Government and looking to build partnerships;

Food Innovation Presentation

Darren Stott and David Van Seters of Greenchain Consulting presented an update for the ongoing Food Innovation project including an update on the working group, Fermentation Hub Business Concept and Market District Expansion planning.

- Council expressed support for continuing to explore the Fermentation Hub concept;
- Council suggested emphasizing the importance of food security and cultural diversity for future research.



Granville Island Online Marketplace

Tom Lancaster, General Manager, presented initial ideas for an online marketplace for all of Granville Island.

- Council expressed support for the concept, as it would benefit Granville Island tenants;
- Council suggested branding Granville Island gift baskets.

Land Use Targets in the 1999 Reference Document

Tom Lancaster, General Manager, provided an overview of the land use targets in the 1999 Reference Document and explained that the targets did not account for a sustainable financial model. Staff are currently re-evaluating the Reference Document and assessing usefulness for the current context.
